### **Patient Advocates, Stem Cell Leaders Urge United Nations to Reject Ban on Therapeutic Cloning In Open Letter to Kofi Annan**

United Nations Headquarters, New York, NY, October 13, 2004 – The Coalition for the Advancement of Medical Research (CAMR) presented an open letter signed by 125 domestic and international patient groups, scientific societies and academic institutions to Secretary-General Kofi Annan and the General Assembly urging UN decision-makers to reject a vote banning somatic cell nuclear transfer (SCNT), commonly called therapeutic stem cell research. At a briefing attended by mission delegates, Daniel Perry, President of CAMR said, “This letter sends a clear message to all United Nation delegates and policy leaders around the world that any ban on therapeutic cloning research will be strongly opposed. Therapeutic cloning could lead to new treatments and cures for millions worldwide facing incurable diseases and conditions such as cancer, Parkinson’s disease, Alzheimer’s, diabetes, ALS and spinal cord injury. SCNT is not reproductive cloning or creating babies which we all agree is unethical; it is about improving lives.”

CAMR joined forces with the Genetics Policy Institute and the Republic of Korean UN Mission to gather a group of patient advocates. Today’s patient-advocate briefing precedes the start of final UN deliberations on a proposed worldwide treaty sponsored by Costa Rica banning therapeutic cloning research. In the letter, Bill Richardson, Governor of New Mexico and former U.S. Ambassador to the United Nations said, "The resolutions to be discussed by the General Assembly could affect the health and well being of hundreds of millions of people facing intractable diseases in every nation in the world. The United Nations should consider carefully before it attempts to ban a scientific technology that holds infinite promise for the development of treatments for serious illnesses and devastating disabilities."

Bernard Siegel, Executive Director of GPI added, “The proposed UN treaty must be stopped. We should not prohibit scientists from exploring new and important research; we should not discourage funding for ethical research and we must not diminish the hope of millions suffering from diseases and other life threatening conditions. GPI along with leading scientists from around the world oppose this treaty and are urging policy leaders to learn about therapeutic cloning before enacting ill-advised bans. ”
